CANADIAN NEWS:

As you probably know, when Bill C-7 was adopted in March 2021, extending "medical assistance in dying" (MAID) to people not nearing the end of their life, it allowed MAID for people with mental illness as the sole condition underlying their request, with a delay of two years for the implementation of this provision. The law required *an independent review to be carried out by experts respecting recommended protocols, guidance and safeguards to apply to requests made for medical assistance in dying by persons who have a mental illness... no later than the first anniversary of the day on which this Act receives <u>royal assent</u>.*

The expert panel's report is thus expected this week (before March 17, 2022). Its membership includes several known activists for MAID for mental illness, and we do not expect much caution in the report. In a recent article co-authored by Dr. Mona Gupta, the chair of the panel, there is no doubt regarding her opinion on the issue.


CALL TO ACTION:

• We urge all members and supporters (especially, but not only, mental health professionals) to share your views and concerns with your MP, the Ministers of Justice, Health and Mental Health and the media, when the report is tabled this week. Please click here for pertinent contact information.

We recommend that you draft a short (600-word) text now, which can be finalized and sent the day the report is announced or as soon as possible afterwards.

• Another announcement to prepare for:

We expect a Bill to be tabled in Quebec soon, to update the MAID law, following the Commission held in 2021(Report). It will no doubt propose MAID by advance request for dementia as well as other worrisome elements.



• Euthanasia Run Amok (Aka Population Culling)

"The sad truth is that many who choose this option due so out of concern (not necessarily validated) of burdening their families. Others choose it out of loneliness, exacerbated by COVID lockdowns (as I wrote about here), or because they don't have support, financial, social, or medical. These are manifestations of a societal failure – ones that don't devolve from the patient's medical or mental condition – and these are problems that should invoke social assistance - not population culling. Indeed, as we legitimize – even encourage – this death strategy, we spend less money and less effort on developing palliative care.

Media coverage has worsened the problem, normalizing even hagiographizing the process, reporting on "celebrity endorsements" and euthanasia cases <u>donating organs</u>. "


